## **POLICY**

## **SUBJECT: GRADUATION REQUIREMENTS**

To graduate from the Alfred-Almond Central School District, a student must complete or exceed the requirements outlined in Part 100 of the Commissioner's Regulations. The Board of Education reserves the right to establish graduation requirements that exceed the minimum standards defined by the New York State Regents.

## Regents Diploma with Honors

The District may award a Regents Diploma with Honors or a Regents Diploma with Advanced Designation with Honors to students who receive an average of ninety percent (90%) on all Regents examinations. A student who has substituted no more than two (2) alternative assessments for a Regents examination as approved by Commissioner's Regulations Section 100.2(f) may also receive a Regents Diploma with Honors. However, the student's actual score on the substituted alternative assessment will not factor into the ninety percent (90%) calculation.

## Regents Diploma

Students that complete 25 units of credit and satisfy the minimum requirements stated in Commissioner's Regulations Part 100 will be issued a Regents Diploma from Alfred-Almond High School.

The required 25 units of credits must include the requirements of the Commissioner's Regulations Part 100 and the additional credits stipulated below.

All students must carry a minimum of six (6) units of credit during each school year to attain this requirement.

Due to the COVID-19 pandemic, the BOE waves the local computer (1 unit of credit) requirement for graduation for the Classes of 2023 and 2024, reducing it to a 0.5 unit of credit requirement. The requirement exemption will begin after the 2nd marking period (1/22/21) for implementation at the beginning of the third marking period (1/25/2021). The one (1) unit of credit requirement will resume for the class of 2025 and the following cohorts.
