SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. The Alfred-Almond Central School District will use ARP ESSER funds for outdoor learning spaces, including a pavilion, amphitheater, outdoor classroom, and associated site work/pathways/drainage that aligns with and promotes the implementation of prevention and mitigation strategies consistent with the most recent CDC guidance on reopening schools. The addition of the outdoor learning spaces will support safe social distancing and continue to promote the safe return to in-person instruction. The district will utilize these spaces to implement evidence-based activities and instruction to meet the comprehensive social-emotional and academic needs of students, and address learning loss.

The Alfred-Almond Central School District will utilize multiple data points to identify student needs, monitor student progress, and drive continuous improvement throughout implementation of its planned ARP ESSER activities. The district will utilize the required 20% reserve of funds to address the academic impact of lost instructional time through the following: Activity #16: (20% Reserve-Learning Loss) Project Adventure evidence-based curriculum and challenge course elements designed to improve students social-emotional learning and promote development of their mental health, wellness, and relationship building skills. Project Adventure is an evidence-based, curriculum-aligned enrichment activity that will be implemented throughout the school year, including summer learning and enrichment, to integrate social emotional learning that will address the academic impact of lost instructional time. (Evidence-based curriculum and course elements \$170,421; Staff facilitator training \$60,000 = \$230,421)

Activity #15: (20% Reserve-Learning Loss) Promethean Board Displays in the outdoor classroom will support implementation of evidence-based activities related to curriculum-aligned summer learning and enrichment and supplemental after-school programming, including provision of outdoor classroom instruction and support for high dosage tutoring during the summer months to address the academic impact of lost instructional time (3 units x 4,995/unit = 14,985)

Activity #15: (20% Reserve-Learning Loss) Enclosures (i.e., cabinets) for Promethean Board Displays in the outdoor classroom will support implementation of evidence-based activities related to curriculum-aligned summer learning and enrichment and supplemental after-school programming, including provision of outdoor classroom instruction and support for high dosage tutoring during the summer months to address the academic impact of lost instructional time (3 cabinets x \$1,100/cabinet = \$3,300)
