Dear Community Members:

The district is in the process of preparing for the annual election and budget vote for the funding of the 2020–21 school year budget. In view of that, we invite you to attend the annual school budget presentation on June 1 at 6:00 p.m. This presentation will take place virtually. Additionally, in accordance with the Governor's executive order, all voting must take place through absentee ballot. Information is being mailed via post card to all residents with instructions on how to vote. Completed ballots must be at the district by 5:00 p.m. on June 9, 2020.

On May 13, 2020, the AACSD Board of Education (BOE) approved a 2020-21 school budget in the amount of \$14,355,618 to present to district residents. Developing this budget was a very difficult and challenging task in light of the current economic conditions and challenges placed on school districts due to the COVID-19 pandemic. The budget can be best described as conservative and likely will be fluid as we move through the 2020-21 school year. It is based on the information provided to school districts by Governor Cuomo and the New York State Department of Education to date. However, it must be acknowledged that there are still numerous items related to school funding and opening schools for 2020-21 that are yet to be finalized and/or defined during the coming months and could impact our financial plans.

The following highlights some of the key factors related to the proposed budget:

- The proposed budget assumes no increase in New York State Foundation Aid for the 2020-21 fiscal year. This was approximately a \$300,000 decrease in anticipated revenues.
- Compared to the 2019-20 budget, the proposed 2020-21 budget is approximately \$199,000 more, a 1.4 percent increase.
- Depending on the final county property assessments, the proposed budget will have a tax increase of less than 2 percent. At this time, we are estimating 1.8 to 1.9 percent.
- The proposed budget does not eliminate or reduce any academic programs, student support services or student extracurricular programs.
- At this time, the BOE is not planning to eliminate any employee positions. However, the district's administrative team has restructured several positions and functions to achieve fiscal efficiencies and meet organizational needs.
- During the past several years, the BOE has planned and set aside funds for the specific purpose of having some resources available to maintain the quality and excellence of our district's educational services in difficult fiscal times. Some of this funding was used to balance the proposed 2020-21 budget. This is the same successful strategy we used prior to and during the recession that began in 2008.
- We do not anticipate that our upcoming capital projects focusing on energy efficiencies, school
 security, classroom renovations and building maintenance to be impacted. Funding for these
 endeavors seem secure and come from different state and federal sources, as well as the
 district's capital reserve funds.
- Lastly, Governor Cuomo has stated several times that it may be necessary to "take back" some promised educational funding at some point in the 2020-21 fiscal year. The possible amount(s) and state aid sources have not been defined. The proposed 2020-21 budget and funds set aside would allow some limited flexibility to address any reductions. However, at this time, without knowing any specific details everything related to this would simply be speculation and we will have to address it if and when it happens.

Annual Budget

Shall the annual budget for the 2020-2021 school year, as proposed by the Board of Education of Alfred-Almond Central School, be approved in the amount of \$14,355,618?

Proposition 1 – Purchase of two (2) 66-passenger School Bus

Shall the proposition authorizing the Board of Education to purchase two (2) 66-passenger school buses at a maximum estimated cost of \$239,000 be approved?

Proposition 2 – Almond Library and Alfred Box of Books Library

Shall the Board of Education of the Alfred-Almond Central School District, at the request of the Alfred Box of Books Library and the Almond Library, be authorized to levy the following appropriation for the support of the libraries by \$185,302 annually, with annual distribution being \$100,939 to the Alfred Box of Books Library and \$84,363 to the Almond Library?
